- A. <u>Motion</u>: The ENC Finance Committee recommends the ENC Board approve an expenditure of \$500.00 as a contribution to "Neighborhood Council Budget Day" to help fund the NC Budget Advocates expenses. This will be funded from the ENC's 2024-2025 Fiscal Year allocation. Vote 4 Yes / 0 No
- B. <u>Motion</u>: The ENC Finance Committee recommends the ENC Board approve an expenditure of \$500.00 as a contribution to the Congress of Neighborhoods. This will be funded from the ENC's 2024-2025 Fiscal Year allocation. Vote 4 Yes / 0 No
- C. <u>NPG Application to Consider: AYSO Region 33</u> American Youth Soccer Organization (AYSO) Region 33, based in Encino, CA, is seeking NPG funding of \$2,395.00 to host two free youth soccer clinics for children under the age of 12. #### 7. <u>NEW BUSINESS</u>:

**A. MOTION to support** <u>CF 25-0002-S13 Resolution</u> (Padilla - Blumenfield) relative to including in the City's 2025-26 State Legislative Program a position on <u>AB 467 (Fong)</u>, which would extend the authorization for Neighborhood Councils to use alternate teleconferencing provisions to conduct meetings remotely until January 1, 2031 (amended to 2030). Community Impact Statement to be filed.

Chief Legislative Analyst <u>report</u>, <u>dated April 8, 2025</u>, relative to a <u>Resolution</u> in support of <u>AB</u> <u>467 (Fong)</u>, Open meetings: Teleconferences: Neighborhood Councils.

**B. Resolution on California Senate Bill 79 (SB 79) -** Motion to file a CIS supporting <u>CF</u> <u>25-0002-S19</u> (Lee - Park) the City Council's resolution opposing <u>SB79</u>. The Encino Neighborhood Council will discuss and consider the adoption of a resolution urging the Los Angeles City Council to oppose SB 79 as currently written. **MOTION**: The Encino Neighborhood Council strongly urges the Los Angeles City Council to OPPOSE Senate Bill 79 in its current form because it would destroy single-family neighborhoods. For more information about SB 79 and how it will impact Encino, please watch the <u>video presentation</u> from the Encino Property Owners Association from April 2025.

**C. MOTION to support** <u>Council File 25-0600-S7</u> Budget <u>Motion 6</u> (Park - Padilla), dated May 22, 2025, relative to restoring funding to the Neighborhood Council Fund. Community Impact Statement to be filed.

Currently, each Neighborhood Council receives an annual allocation of \$32,000 but the Fiscal Year 2025-2026 Budget reduces that amount to \$25,000. This motion seeks to restore the allocation to the existing \$32,000 for each NC, for a total amount of \$693,000. Also see <u>Encino NC Community Impact Statement</u> filed on <u>Council File 25-0600</u>.

**D**. MOTION: Encino Neighborhood Council Public Safety Committee recommends the ENC submit a CIS supporting <u>Council File: 25-0445</u> which identifies homeless data silos that can be integrated in order to improve data analysis and improve homeless system operations. Public Safety Committee April 2025 (3 yes - 0 No - 1 abstain)

E. Utility Box Murals - The Encino NC was recently informed that there are efforts by one or more organizations to paint utility boxes in Encino with murals.
MOTION that the Encino NC inform Council District 4 and the Department of Transportation of its interest in overseeing and coordinating the painting of utility boxes with murals. The ENC will identify specific utility box locations along major streets within its boundaries, such as Ventura Boulevard, Burbank Boulevard, Balboa Boulevard, White Oak Avenue and the east side of Lindley Avenue and the south side of Victory Boulevard.

**F.** Formation of an Ad Hoc Post-Election Onboarding and Orientation Committee - As discussed at the Executive Committee meeting, this committee would be established to support new board members following the recent election, helping to ensure a smooth transition through structured orientation, guidance, and access to key resources and information. <u>MOTION</u> that the Encino NC form an Ad Hoc Post-Election Onboarding and Orientation Committee.

#### SB 411 Updates:

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.

(C) The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall

provide an opportunity for the public to address the legislative body and offer comments in real time.

(D) Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.

(E) (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph (D), to provide public comment until that timed public comment period has elapsed.

(ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.

(iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.
