- 1. Record meeting. Call to Order. Roll call. Determination of quorum. Comments from chair.
- **2. Public Comment on Non-Agenda Items:** Public comments on non-agenda items are limited to *TWO (2) MINUTES* per speaker. Time may be adjusted at the Chair's discretion. For those calling in, press *9 on your phone to raise your hand to speak. For those using Zoom Webinar, use the "raise your hand" feature to speak.

- 4. New Business Motion, Discussion, and Voting may be taken on all Items:
- A. **Update on Senate Bill 79 (Council File 25-0002-S19)** Informational item. The ENC has previously voted to file a CIS in support of CF-25-0002-S19. No action is required at this time.
- B. **Metro Orange Line Request for Presentation -**Discussion and possible action: The ENC will consider reaching out to Metro to request a presentation regarding future plans, upgrades, or changes to the Metro Orange Line that impact the Encino community.
- C. Illegal Fireworks at Bel Air Church Parking Lot (Mulholland Drive) Discussion and possible action: The ENC will consider a motion to support the Bel Air Church and request intervention from the City Council and appropriate departments to address ongoing incidents of illegal fireworks at the church's parking lot. What steps can the city take to assist in resolving this issue?
- D. Illegal Fireworks on Mulholland Drive at various overlook locations including the Mulholland Overlook at Encino Hills Drive & Mulholland. Motion: In response to community concerns regarding wildfire risk, the ENC will request that Bel Air Church take measures to prevent unauthorized access to their parking lot for the purpose of using illegal fireworks. Additionally, the ENC will advocate on behalf of the Church to the City to expedite any necessary permits or address bureaucratic barriers to implementing these safety measures.
- E. **Fire Hazards in the Sepulveda Basin** Brush clearance and fire hazard mitigation that the City of LA, LA County and Arm Corp of Engineers are responsible for Discuss how the ENC can advocate for attention to this issue along with fire dept inspection for residential brush clearance along Oxnard and Louise Ave. North of Burbank.
- F. **Shade Structure for the Toddler Playground at Balboa Park -** Discussion and possible action: The ENC will consider drafting a resolution requesting the installation of a shade structure over the toddler section of the jungle gym at Balboa Park. This resolution would be directed to CD6, LA City Recreation and Parks, and other appropriate legislative representatives to advocate for safer play conditions during hot and sunny weather.
- G. Election Results Update and Planning for July 23rd General Board

- **Meeting -** Discussion item. The ENC's election results are expected to be certified and published the day following this Executive Committee meeting. We will provide a recap of the election and highlight voter turnout and engagement. The next General Board meeting will take place in person on Tuesday, July 23rd, with newly elected board members in attendance. The committee will discuss how to welcome new members, including the potential for providing refreshments or food, and how to do so in a professional and appropriate manner.
- H. Support for Council File 24-1480 Direct Contracting with Homeless Service Providers- Discussion and possible action: The ENC will consider submitting a Community Impact Statement (CIS) in support of Council File 24-1480, which would allow the City of Los Angeles to bypass the Los Angeles Homeless Services Authority (LAHSA) and contract directly with homeless service providers. This measure aims to increase efficiency, accountability, and responsiveness in addressing homelessness in the city.

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that

prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.

(C) The eligible legislative body shall not require public comments to be submitted in

- advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time.
- (D) Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.
- (E) (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph
- (D), to provide public comment until that timed public comment period has elapsed. (ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment. (iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.
