Roy sent a message to both the mayor's office and Rick Caruso's office stating he is in disagreement with the statements made in the video. He stated Caruso shouldn't have said that the city and Mayor aren't doing anything. He (Roy) said that they are making progress, and did not ask for a meeting because the city was not taking any action. He feels blindsided for being included in political messaging which misrepresents his views and the facts.

There was a Facebook page post made by an ENC member about the Sepulveda Basin visit with Rick Caruso that was inappropriate.

There have been a lot of burglary suspect arrests from LAPD and surrounding agencies.

Supvervisor Lindsey Horvath: Katie Abrams, KAbrams@bos.lacounty.gov not present, but updates shared: They have approved a proclamation of local emergency for federal immigration actions, and that empowers the county to mobilize resources, expedite contracting and procurement, coordinate interagency response, and request state and federal assistance to protect and stabilize impacted communities. This will be in effect until it is terminated by the board.

An LA County Small business resiliency fund was launched on Sept 29 with a deadline of Oct 31 to supply grant money of up to \$5000 in direct relief to small businesses across LA that experienced economic hardship following federal immigration enforcement actions.

Update from LAFD Battalion Chief Barna- For past two days in collaboration with LAHSA, rec and park and LA Sanitation there has been a homeless cleanup on the South side of Encino creek along Burbank with 5 encampments being cleared.

Safety issue was discovered, the trail along the LA River just north of the golf course on the south bank has been compromised by a turn in the river. The trail will be closed until further notice. If going out for Halloween please wear glow sticks or a light to make yourself visible to avoid pedestrian/car incidents. Do not wear masks that block vision and keep an eye on all children in the streets. Do not use open flames for decorations, use battery operated candles.

No camping signs are being posted in the basin to make illegal camping easier to enforce

Motion: ENC demands action from public officials and City departments to address dangerous conditions and property damage caused by ground water seepage on Ballina Canyon Rd and Red Rose Dr. This includes communication such as letters, emails and public comments made by the Public Safety Committee Chair (Public Safety passed 4-0)

#### SB 411 Updates:

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.

(C) The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time.

- (D) Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.
- (E) (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph
- (D), to provide public comment until that timed public comment period has elapsed.
- (ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.
- (iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.
