5. New Business:

1. ZA-2026-1370-ADJ-F 4754 N. Densmore Ave. Adjustment of a fence height at an existing school. **Case Description:** The project involves the construction of a new development. Based on the case code suffixes, this includes an Adjustment (ADJ) and a Fences/Walls (F) request. Discussion and a possible vote.

A presentation was made by two representatives of the Valley Beth Shalom about the Expansions Project. Discussion was had and a motion was made by Diane Rosen for the PLU Committee to recommend to the ENC Board to approve the plan presented concerning the expansion of the school at 4754 N. Densmore Ave. The motion was 2nd by Matthew May. The vote was Kelvin Tolbert –yes Diane Rosen – yes Pilar DeFreest – yes Rachel Perry – yes Matthew May – yes and Laure Stevens yes - the motioned passed 6 yes – 0 no.

2. ZA-2010-1208-CUB-CU-PAZ CVS 16461 Ventura Blvd – refers to a request for a Conditional Use Permit (CUB/CU) and plan approval (PA2) located at **16461 W. VENTURA BLVD** in Encino. This file pertains to ongoing planning, typically involving the sale of alcoholic beverages or operational changes for a commercial property in the Sherman Oaks - Studio City - Toluca Lake - Cahuenga Pass area. Discussion and a possible vote.

A presentation was made by a representative, Bruce Evans, of CVS. Discussion was had and a motion was made by Pilar DeFreest for the PLU committee to recommend to the ENC General Board approve the re-issuance of the Alcohol license for CVS. The motion was 2nd by Diane Rosen. The vote was Kelvin Tolbert –yes Diane Rosen – yes Pilar DeFreest – yes Rachel Perry – yes Matthew May – yes and

Laure Stevens yes - the motioned passed 6 yes – 0 no.

3. 4917 Genesta Ave. - Pavletich Electric & Communication, INC., will be installing 3 carports in a gated parking lot in back of an office building. 2 of the carports will have solar panels and the third will not have solar panels. On the north of the property there are apartment buildings, to the east is a park, to the west is parking lots and commercial businesses, and to the south there are commercial businesses.

Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1. **California Government Code Section 54953.8(b)(3).**

The legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time. **California Government Code Section 54953.8(b)(4).**

Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate. **California Government Code Section 54953.8(b)(5),**

A legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to paragraph (5), to provide public comment until that timed public comment period has elapsed. **California Government Code Section 54953.8(b)(6)(A),**

A legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to paragraph (5), or otherwise be recognized for the purpose of providing public comment. **California Government Code Section 54953.8(b)(6)(B).**

The Encino Neighborhood Council (ENC) is a Certified Neighborhood Council of the City of Los Angeles which ADVISES City, other Governmental Officials’ and the Community on issues or concerns that are affecting the community of ENCINO. The ENC is made up of volunteers who are ELECTED by the community who live, work or otherwise are involved in the community of ENCINO. The ENC also makes appropriations of City Funds for Community Projects and needs as requested and approved by various committees and the general board.
