2. Comments from chair

I received a call from Congressman Sherman notifying me that there is \$772,700 in the US budget for cameras in the West Valley LAP Division and establishing a Real Time Crime Center. Advised that this is a result of ENC's advocacy efforts to Sherman.

Year-to-date burglaries are down 51% in Encino. According to West Valley Commanding Officer Captain Wendling this is a result of increased resources in Encino after ENC and EPOA brought significant media attention to the crime in Encino.

4. Discussion and possible Motion: Regarding offer of a free CPR class by LAFD Battalion Chief Robert Barna.

Motion: Public Safety committee recommends ENC have free CPR class held by LAFD at mutually convenient location.

- 5. Discussion and Motion:** ENC Public Safety Committee recommends submitting a free PSA for digital bus stop digital billboards reminding users of electric scooters and bikes of the proper riding and parking rules. - 6. Motion:** ENC Public Safety Committee recommends ENC prioritize advocacy for LAPD to integrate crime reporting data with crimemapping.com which stopped receiving LAPD data in March 2024. This includes communication such as official letters, emails, submitting a CIS and public comments made by the President or Public Safety Committee Chair.

- 7. Motion:** ENC Public Safety Committee recommends ENC prioritize advocacy for LAPD to take steps to reduce hold times on the LAPD non-emergency line 877-ASK-LAPD and add an option to send non-emergency text messages. This includes communication such as official letters, emails, submitting a CIS and public comments made by the President or Public Safety Committee Chair.

Roy/Adam: Passes 4-0 (RN, KT, JL, AW)

- 8. Discussion and possible Motion:** Discussion about Creators Inc house located at 17623 Weddington St. This house is used by social media influencers and has generated a lot of complaints by the people who live near it.

No action taken until we hear specific complaints from neighbors.

- 9. Motion:** ENC Public Safety Committee recommends ENC support LAPD for National Coffee with a Cop Day on October 7 in any non-financial way needed. And also recommends spending up to \$150 in support of the event to pay for coffee and event promotion. Coffee with a Cop provides access and opportunity for distraction-free conversations with local police officers.

- 10. Motion:** ENC Public Safety Committee recommends ENC support LAPD for National Night Out on August 4 in any non-financial way needed. National Night Out is an annual event designed to foster the relationship between law enforcement and the community. West Valley LAPD station will have a movie in the park adjacent to the police station on August 4.

Next Public Safety Committee Meeting August 10, 2026

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1. **California Government Code Section 54953.8(b)(3).**

The legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time. **California Government Code Section 54953.8(b)(4).**

Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate. **California Government Code Section 54953.8(b)(5),**

A legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to paragraph (5), to provide public comment until that timed public comment period has elapsed. **California Government Code Section 54953.8(b)(6)(A),**

A legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to paragraph (5), or otherwise be recognized for the purpose of providing public comment. **California Government Code Section 54953.8(b)(6)(B).**

The Encino Neighborhood Council (ENC) is a Certified Neighborhood Council of the City of Los Angeles which ADVISES City, other Governmental Officials' and the Community on issues or concerns that are affecting the community of ENCINO. The ENC is made up of volunteers who are ELECTED by the community who live, work or otherwise are involved in the community of ENCINO.
