- Veterans Tribute Park Proposed for the Sepulveda Basin. Review of design to date. Final meeting will be held on March 8th from 9:30am–12:30pm at the National Guard Armory, 17330 Victory Park Blvd. (at Louise)
- Motion to approve a Neighborhood Purposes Grant request from the San Fernando Valley Audubon Society in the amount of \$4,000 to support the Sepulveda Basin Environmental Education Program.
- Motion to approve funding of up to \$350 for the purchase of books related to gardening with California native plants for the Encino-Tarzana Branch Library.
- Motion to approve funds of up to \$9,000 for the replacement of the historic flagpole at Los Encinos State Historic Park.
- Motion to support Council File 13-1352 Partnerships to Combat Prostitution; including the filing of a Community Impact Statement in support. Prostitution along Sepulveda Blvd and other areas of the community spills over into local parks including the Sepulveda Basin. The result is trash that includes hazardous waste, and an otherwise unsavory and unsafe environment for park goers and wildlife. http://cityclerk.lacity.org/lacityclerkconnect/
- Motion to support Council File 12-0899-S1 Los Angeles Park Ranger Program; including the filing of a Community Impact Statement in support of expanding the Park Ranger Program to Optimum Program Level. Community Impact Statement to request that Park Rangers be assigned daily to the heavily used Sepulveda Basin regional park where there is a strong need for the positive educational and enforcement role of the Park Rangers. http://cityclerk.lacity.org/lacityclerkconnect/
- Motion to support Council File 13-1580 Los Angeles Parks and Hillside Areas/Rodent Population Control/Use of Poisons Policies, including the filing of a Community Impact Statement. Anticoagulant poisons kill more than rats and gophers. They also kill hawks, owls, bobcats, mountain lions, dogs, and cats, the very animals capable of controlling rodents in a natural manner. These poisons pose an "unreasonable risk" to the environment and should be banned from use by City departments. http://cityclerk.lacity.org/lacityclerkconnect/
