“To support, create and sustain solutions to homelessness in Los Angeles County by providing leadership, advocacy, planning, and management of program funding.”




- LAHSA was formed in 1993
- Joint Powers Authority formed by the Los Angeles County Board of Supervisors and the Los Angeles Mayor and City Council
- 10 member commission governs LAHSA
- Coordinate and manage over \$243 million annually in Federal, State, County and City funds for programs that provide:
 - Shelter
 - Housing
 - Services to homeless persons in Los Angeles City and County

“LAHSA's primary role is to coordinate the effective and efficient utilization of Federal and local funding in providing services to homeless people throughout Los Angeles City and County.”

- Education and Coordination




- Apply for Federal Funds on Behalf of Los Angeles

- Operate the Homeless Management Information System (HMIS)


