## SECTION II - PROJECT DESCRIPTION

4) Please describe the purpose and intent of the grant.

Our organization is all volunteer. We assemble and distribute CarePacks for the homeless — both on the streets, and to shelters, food pantries, churches, temples, and other organizations with a homeless outreach (such as L.A. Dept. of Mental Health and LAUSD). Our CarePacks are sturdy backpacks, filled with food, water, clothing, blanket, and many essential personal care items, such as washcloth, shampoo, soap, toilet paper, lip balm, lotion, toothpaste, toothbrush, and much more.

This program is conducted year-round. The purpose of this grant is to give the Encino Neighborhood Council the opportunity to participate in this valuable program by providing funding for approximately 90 complete CarePacks for our homeless neighbors.

5) How will this grant be used to primarily support or serve a public purpose and benefit the public at-large. (Grants cannot be used as rewards or prizes for individuals)

100% of this grant money will be used to purchase the items needed for the CarePacks. We are very careful to shop around for the best possible prices, and to try to get discounts for bulk ordering. Each CarePack is to be given to the homeless men, women and children on the streets. Often, our CarePacks are used to establish a relationship of trust. From there, the hope is to help connect the CarePack recipient with the help needed to get them off the streets. Our belief is that while permanent housing is critical, we must also address the basic needs of the here and now.
