

Please describe the purpose and intent of the grant.

Los Angeles Fire Department Station 83 in Encino (4960 Balboa Blvd.) was opened January 19, 2006. The landscaping has not been upgraded since then, and has become unsightly and difficult to maintain. The City does not provide any funding for maintenance of the landscaping, and the firefighters have been paying for necessary services out of their own pockets. An upgrade to more attractive features and more easily-maintained drought resistent plants is long overdue. This landscaping will be complementary to that at the LADWP distribution across the street. All trees will be retained, schematics are attached.

5) How will this grant be used to primarily support or serve a public purpose and benefit the public at-large. (Grants cannot be used as rewards or prizes for individuals)

The fire station is positioned close to Ventura Boulevard, the major Encino thouroughfare. Many people in the area walk through the grounds on their way to and from appointments, meetings, etc. Improving the appearance will have a very positive effect on the entire community, providing a shady respite from the summer heat. Most of the plants will be both drought resistant and attractive to birds & bees.





LOS ANGELES FIRE DEPARTMENT STATION 83 LANDSCAPE REMODEL SCHEMATICS









