

To whom it may concern,

Over the last few years, Mulholland has increasingly turned to diversity, equity, and inclusion by designing and implementing school policies to resolve inequities. Teachers, for example, order more classroom books with stories that better reflect students' racial diversity. In addition, the district mandates anti-bias training to prevent stereotyping that can threaten student progress, such as setting lower expectations for students of color. On the micro level, these changes open educators' eyes to just how inequitable schools can be and bring into focus how to start resolving inequities and making Mulholland Middle School more diverse, equitable, inclusive, and more effective through a school garden project.

Our garden education team observed various special education classroom teachers. It worked closely with teachers to provide guidance and best practices to include all students in a garden-based learning project. We will search online to gather inclusion strategies and adaptive gardening practices that best apply to garden-based learning. Finally, we will share with other garden educators, as well as general and special education teachers' information regarding growing various fruits and vegetables, the importance of gardening as a lifelong hobby, and the development of student self-reliance.

One key to the success of Mulholland's School Garden Project is developing community buy-in. The collaborative community partnership strengthens an ongoing reciprocal relationship that fosters safe and inclusive spaces. As a result, continuous assessment of program impact can be accessible and community-centered. Mulholland will complete the garden project by June 2023.

4) Please describe the purpose and intent of the grant.

Each year, FoLAR organizes the annual Great LA River CleanUp. This year the event will be renamed "Earth With Us: The Great LA River CleanUp", and will be hosted on April 15 and April 22 at seven sites along the Los Angeles River. The first site in ENC boundaries is a river cleanup at the Sepulveda Basin Sports Complex on April 15, which will have capacity for 500 volunteers and can be expected to remove 11,250 pounds of trash from the LA River. The second site is a habitat restoration and creek cleanup event at the Sepulveda Basin Wildlife Reserve on April 22, in which up to 500 volunteers will remove invasive plants with California Native Plant Society and attend a 1-hour bird walk with Audubon Society of San Fernando Valley. In total, these two sites are estimated to cost \$24,620. The funds from this grant would help cover the costs of permit fees, porta-potties, and gloves for the two Encino sites.

5) How will this grant be used to primarily support or serve a public purpose and benefit the public at-large. (Grants cannot be used as rewards or prizes for individuals)

Over two weekends in April, FoLAR's Earth With Us: The Great LA River CleanUp will mobilize thousands of volunteers to work together to remove trash and invasive plants from the LA River and its tributaries. The sites within ENC boundaries are critical areas to restore because they are within the Sepulveda Basin and are characterized by verdant riparian habitat and a wide variety of urban wildlife, including over 200 species of birds. The lush vegetation along this stretch of River makes it easy for trash to snag and pollute the water that is so important to wildlife and Angelenos alike, while invasive plant species reduce the liveable habitat for local and migratory birds. Our Earth With Us events offer volunteers an opportunity to make an immediate, hands-on impact on LA's urban ecosystems and understand firsthand how a healthy and thriving LA River benefits River-adjacent communities like Encino, visitors to the LA River, and LA's urban wildlife.
